To Whom It May Concern:

This firm represents Conan Properties International LLC ("CPI"), the owner of the CONAN property (a/k/a CONAN THE BARBARIAN), including the related copyrights and trademarks. The CONAN character and trademarks have been and are being used for a wide variety of goods and services, including, for example, books, graphic novels, sculptures, swords, interactive games, movies, toys and other entertainment goods and services. With this extensive and long-term use of CONAN, CPI has established goodwill and fame of immeasurable value in the trademarks and copyrights associated with CONAN.

CPI and its predecessors have gone to great effort and expense to protect and enforce its intellectual property rights in CONAN, including, for example, by securing numerous trademark registrations for CONAN and CONAN THE BARBARIAN, throughout the world as well as numerous copyright filings. These filings include U.S. federal registrations numbered: 1,242,975, 1,374,714, 1,254,593, 1,835,249, 2,249,301, 2,193,489, 2,522,082 and 2,522,083.

It has come to our attention that you are selling audio books containing stories by Robert E. Howard featuring his character CONAN THE BARBARIAN on your website www.brokensea.com/conan. The logo you are using to advertise these products infringes CPI's trademark rights in that it is substantially similar to the style of registered CONAN trademarks owned by CPI, and therefore creates a likelihood of confusion in the marketplace as to the source of the products. Additionally, use of the CONAN trademark to identify your audio books constitutes unfair competition and falsely suggests that CPI has sponsored, authorized and/or is otherwise connected with you or your goods.


